ABUSE/NEGLECT REPORTING REMINDER:

Remember that suspected cases of child abuse/neglect must be reported to <u>both</u> DCF and the Archdiocese. All adults are legally obligated to report suspected abuse to DCF. When submitting such reports, remember that schools must also report to the Archdiocese. This can be done in one of two ways:

- 1.) Calling the Safe Environment number at 305-215-6635
- 2.) Submitting an Abuse Reporting Form (available here and in the E-Library)

We are happy to announce that Ms. Nyce Daniels, retired principal of Holy Family School, is now monitoring the Safe Environment phone, with backup support from Sr. Elizabeth Worley.

AHCA CLEARINGHOUSE FOR SCHOOL FINGERPRINTING:

We are in the fifth month of the implementation of the transition to the AHCA Clearinghouse for fingerprinting of school employees and vendors. Below please find updates and reminders:

- Although the Clearinghouse issues determinations of eligibility to serve, an ADOM individual's eligibility to serve is granted by the Fingerprinting Office of the Archdiocese of Miami. We apply our own standards on top of the standards stipulated by the FDOE's statutes.
- Teachers who are currently in the Clearinghouse do not need to get fingerprinted again for certification. Such teachers need to inform the FDOE that they are already in the Clearinghouse.
- Principals are the Owner/Operator of your school. Your access to the Clearinghouse gives you the ability to add your schools to your employees' rosters in the Clearinghouse. This should be done within five days of an employee's hire.
- Principals should not be delegating Clearinghouse responsibilities to other employees.
- We take very seriously the legal and moral responsibility to protect sensitive information submitted on the spreadsheets. Therefore, a gentle reminder that all spreadsheets sent to us must be password protected. Otherwise, in order to protect the sensitive information on the spreadsheet, we will delete it from our server and the system and return the email so it can be submitted properly.
- Individuals should not be sent for fingerprinting without having received the Livescan document after the creation of the profile. Some folks have just shown up for fingerprinting and we will need to turn them away, unfortunately.

If the certification coordinator at your school has changed within the past two school years, kindly provide the updated information to teacher.certification@theadom.org.

The deadline for PMP registration is **October 1, 2025**. We will continue following the 2024-2025 PMP Handbook this year. The handbook can be found in **E-Library** under **Education—Schools—Certification**. See the FAQs below. If you still have questions, please email teacher.certification@theadom.org.


- Who should do the PMP?
 - o Only teachers with a current Temporary Certificate in hand.
- How can we tell if a teacher must do the PMP?
 - o By reading the **Statement of Eligibility.** It will read: "Completion of a Florida approved Professional Education Competence Program documented by your employer."
- How do we enroll a teacher?
 - o **By October 1**st, send the completed **Teacher Enrollment Form** (pg. 10), copies of the **Temporary Certificate and SOE**, as well as the \$50.00 fee (a check payable to "ADOM")
 - Archdiocese of Miami
 - Attn: Ana Umana
 - 9401 Biscayne Boulevard
 - Miami Shores, FL 33138
- When does the program begin?
 - o October 1st
- What qualifications does the mentor need to have?
 - o Minimum of three (3) years of successful teaching experience in Catholic schools
 - o Professional Certificate
 - o Trained in Clinical Education
- When does the program end?
 - o May 1st
- What do we do when the program is completed?
 - o Send *ONLY* pages 9-27 (PMP Packet) via email to Ana Umana at <u>teacher.certification@theadom.org</u>. You will also be scanning and sending all evidence. The portfolio stays at the school.
- What happens next?
 - o Once the completed program has been sent to the Office of Catholic Schools (OCS) and verified, the OCS will submit the PMP to the FLDOE.

STEP UP:

Review Student Enrollment Information in EMA

As the 2025–2026 school year begins, now is the perfect time to double-check that all scholarship students are correctly listed and approved in your Education Market Assistant (EMA) account. Catching discrepancies early helps prevent payment delays and ensures a smoother experience for both families and school staff.

One of the most common discrepancies is incorrect student grade levels. Here's how to handle it:

- If the parent applied for the wrong grade level: Please ask the parent to contact our Engagement Center directly to make the correction.
- If the school enrolled the student in the wrong grade level: Withdraw the student and re-enroll them using the correct grade level. Be sure to notify the guardian that they will need to re-accept the updated enrollment.
