## Human Resources

1. Employee Assistance Program Orientation. As shared in our ADOM Health Plan Annual Enrollment materials, the Archdiocese of Miami has contracted the services of an Employee Assistance Program with ComPsych, the world's largest provider of EAPs; integrating behavioral health, wellness, work-life, crisis intervention and related services to assist employees during times of life's challenges. ComPsych has other arch/diocesan clients and has customized its services for us. Employees (and their family household members!) will be able to contact the EAP privately, on their own; they may be referred informally with HR joining them on an initial call; or they may be formally referred as part of a planned or corrective action. All counseling sessions are confidential.

**ComPsych's** representative assigned to our account will hold an orientation for HR persons/bookkeepers/business managers to provide you with information on the scope of resources as well as the process for accessing the benefit. # **Building Services**

ATTENTION: please be aware that all ADOM entities that have an elevator must be in compliance with the following elevator regulation prior to December 31, 2023.

While it may appear that we have plenty of time to address this requirement, please note that there are over 80,000 elevators in the State of Florida, and if you wait too long to plan, budget, and implement the required work, you will likely find it difficult to find a contractor that can perform the required work prior to the deadline.

Specifically, the State of Florida has adopted a new safety code which requires that all elevators, no matter the age, be retrofitted to include a *DLM (door lock monitor) system* as outlined below:

#### OFFICIAL NOTICE OF CHANGE

#### Dear Elevator Licensee or Elevator Personnel,

The Bureau of Elevator Safety has adopted new ASME Elevator Safety Code A17.3-2015, Safety Code for Existing Elevators. Part of this new Safety Code includes Section 3.10 Operating Devices and Control Equipment, Requirement 3.10.12 System to Monitor and Prevent Automatic Operation of the Elevator with Faulty Door Contact Circuits. All conveyances licensed by the State of Florida Bureau of Elevator Safety must be in compliance of the above Code by December 31, 2023. The Bureau of Elevator Safety encourages all owners of conveyances licensed by the State of Florida to contact your Elevator Company to discuss what your conveyances will need in order to comply with this section of A17.3-2015.

\*\*It is important that all ADOM entities set up a meeting with your elevator maintenance company as soon as possible as required to discuss how this requirement will affect your particular elevator, in order for you to plan accordingly. Attached is a TKElevator notice for your reference.


# **HOMETOWN HEROES**
