

NEW ADMINISTRATOR INSTITUTE (NAI)

The Florida Catholic Conference New Administrators' Institute is a collaborative effort of all seven (Arch)Dioceses in the Province of Miami. The goal is to provide professional development for Catholic school administrators. It is designed as an experience tailored to administrators (principals, midlevels) new to the Florida Catholic school system and those beginning or completing their first or second year as an administrator.

The Institute will take place September 24-26, 2024 at the Marywood Retreat and Conference Center (235 Marywood Dr., St. Johns, FL 32259). Part of the cost is funded through Project RICE and participants only need to pay \$400*, which includes meals and accommodations. Registration fees are due by September 1, 2024. Travel costs must be arranged separately. *The FCC is working with the FLDOE to get the New Administrators' Institute on the approved conference reimbursement list using Title II monies through the North East Florida Educational Consortium (NEFEC). Last year, 67% of the participant's cost was reimbursable by statewide Title II through NEFEC.

PROFESSIONAL DEVELOPMENT DAY – SEPT. 27:
