

Target your recruiting and workforce planning by getting a snapshot of your workforce, from your headcount to the turnover rate, to the breakdown by generation, and more. To do so, access Paylocity's Data Insights Dashboard (your entity HR person can show you how). Here is a snapshot of one of our schools, below, at the current point in time:



OBSERVATIONS: Beginning in the 2023-2024 school year, individuals using the new walk-through and/or summative observation tool will need to have current professional certification in Educational Leadership or possess Clinical Educator Training. These qualifications include all administrators, mid-level administrators, and department chairs.

PRESCHOOL GRANT OPPORTUNITY: American Rescue Plan Act (ARPA) Grant - Round 2

The deadline to apply for Child Care Stabilization Grant Program Round 2 funded through the American Rescue Plan Act (ARPA) is February 28, 2023. If you have not submitted an application please do so to the Early Learning Coalition as soon as possible. Do not wait until the last minute.

Schools/Preschools can apply for this grant if they are deemed child care by the Department of Children and Families (DCF) and meet either condition A or B below:

- A. They were licensed, registered, or regulated under the appropriate state or local law on or before March 11, 2021. In Florida, this includes:
 - Licensed Child Care Facilities
 - Religious Exempt Programs
 - School Readiness Contracted Wrap Around Programs
 - Before and After care School-Age Only Programs (up to age 13) must have DCF determination letter

OR

B. They were licensed, registered or regulated after March 11, 2021 AND are contracted for the School Readiness program.

PROFESSIONAL DEVELOPMENT (BROWARD AND MIAMI-DADE):



FREE FDLRS-South Online Professional Development Opportunities: The following free online Professional Development Alternatives virtual courses will be offered by FDLRS-South from March 6, 2023 through May 12, 2023. Participants will receive inservice credit points for their completion of course activities:

Differentiating Mathematics Instruction (30 MPP) - This course enables educators to develop, increase and demonstrate knowledge about how to apply the guidelines of differentiating instruction to mathematics instruction. Emphasis is on evidencebased practices structured by a responsive decision-making framework in order for all students to achieve at the highest possible level. Content includes how to use pre-assessment, continuous assessment, and summative assessments to design and deliver effective lessons for initial instruction in mathematics and how to effectively use flexible small group instruction to respond to individual learner needs.

- Differentiating Science Instruction (30 MMP) This course enables educators to develop, increase and demonstrate knowledge about applying the guidelines of differentiation to science instruction for the purposes of increasing student achievement for all learners. Content and activities emphasize how to use pre-assessment, continuous assessment, and summative assessments to design and deliver effective science lessons for whole group initial instruction and how to effectively use flexible small group instruction and individualized instruction, when needed, to respond to each student's needs.
- Exploring Structured Literacy (40 MPP) The Exploring Structured Literacy course was designed in response to the 2017 Florida Statute 1012.585(3), which requires that Florida educators in specific coverage areas participate in a minimum of two college credits, or 40 in-service hours of professional learning related to the use of explicit, systematic, and sequential approaches to reading instruction, developing phonemic awareness and implementing multisensory intervention strategies. In order to appropriately meet the literacy needs of all students in the academic environment, this professional learning opportunity emphasizes reading instruction that builds a strong, cumulative, and logical foundation of structured literacy. Components of structured literacy include phonology, sound-symbol correspondences, syllables, morphology, syntax, and semantics.
- Introduction to Assistive Technology (20 MPP) This course enables educators to develop, increase and demonstrate knowledge about assistive technology devices and services and the process of helping students with disabilities select, obtain, and use assistive technology. Content includes information about the impact of identified areas of disability including vision, auditory, physical, communication, intellectual, and cognitive processing, and how assistive technology devices and services provide support.
- Matrix of Services (5 MPP) This course enables educators to develop, increase and demonstrate knowledge about the Matrix of Services. Content and activities examine the requirements for matrix completion and provide the opportunity to accurately complete a matrix for students with disabilities. The course identifies how student educational needs and services impact the matrix funding document.
