EANS:

Your school may have recently received an email from the Florida Department of Education (FLDOE) regarding a release of new funding associated with the EANS program. These emails were sent only to schools that participated in the initial EANS release of funds (i.e. "EANS 1"). If you received such an email, please complete the referenced survey and submit by the deadline of <u>Friday</u>, <u>Dec. 23</u>. Note that the survey link is unique to each school, so you will need to check the email and click the survey link. We are confident that this will enable you to receive further funding from this important program!

Security Cameras in Classrooms: We have received questions as to whether schools can install cameras in classrooms (vs. other areas of the campus) for the purposes of security. After consultation with our attorneys, schools can install classroom cameras, but should note a few considerations:

- Cameras should not utilize audio recording due to Florida laws that do not allow such recording without consent.
- Schools that utilize classroom cameras should include the following statement in the local Parent/Student Handbook: "The school has as its discretion placed surveillance cameras at various locations on the school premises for safety and security purposes."
- The use of surveillance video creates certain legal obligations particularly with recent legal developments related to retention and access of video footage. For example, when video footage is used to determine student disciplinary consequences there is legal authority supporting the proposition that it becomes part of a student record to which a parent is entitled to access upon request. There are also legal obligations to retain video footage that may foreseeably be relevant to a legal proceeding. Therefore, you will need to consider a retention policy both generally and for particular segments.
