#### **Early Release Days:**

We have two Early Release Days scheduled in the month of October. Remember that schools must ensure at least four hours of classes during Early Release Days, not counting lunch (if offered). The Oct. 4 Early Release Day should be dedicated to professional development; schools should not use this day for Faculty Meetings, early dismissal for teachers, etc. The Early Dismissal Day on Oct. 18 may be used for professional development and/or to provide teachers with an opportunity to finalize grades for the first quarter. #### **Election Resources:**
