

ATHLETICS DIRECTORS MEETINGS:

Attendance is mandatory for all new and returning AD's.

BROWARD TITLE I

The PSW will be accessible for schools to submit referrals starting from June 2nd and will remain open through the summer until August 8th.

- There are helpful videos available on the PSW to guide users through the referral process.
- For students who have rolled over and are address eligible, add the referral information, which should include parent consent and academic eligibility. This year, parent contact information is also required.

- When entering information for new students, fill out all fields completely, including demographics and the student's address. Once the student's address is approved, you can proceed to enter the referral information.
- If you have any questions or need assistance, please reach out to your grant facilitator.
- Additionally, instructional videos are provided on the PSW to assist with the referral process.

NEW FCC ACCREDITATION STANDARDS:

The new FCC Accreditation Standards are aligned with NSBECS 2.0 and will be used by all elementary schools in accreditation cycle years 1-6 in the 2025-2026 school year. 
