

**NONPROFIT SECURITY GRANT (FEDERAL):** Per the recent email, the deadline for submission for the <u>federal</u> Nonprofit Security Grant has been extended to May 15 at 5:00 PM. See Dr. Rigg's previous email for more information, including the application form.

**PLAYGROUND EQUIPMENT:** When planning to install new or replacement playground equipment, please remember that playgrounds are a potential liability, so it is critical that the new equipment and safety flooring in all fall areas meets minimum safety standards put forth by the CPSC. For your reference, attached is a copy of the Playground Safety Handbook published by the CPSC.

As a reminder, all contractors installing playground equipment and flooring are required to be licensed, insured, and contracted, in accordance with standard ADOM requirements and we highly recommend that the playground equipment company also be responsible for the installation of the equipment. Upon completion of the playground installation the playground company shall be required to provide the ADOM with copy of all equipment and safety flooring specifications / documentation (certifying the playground installation meets all CPSC requirements) and copies of all closed permits prior to final payment.
